BRIEF HISTORY OF THE ORGANISATION

Mrinaljyoti Rehabilitation Centre is the result of grief and sorrow at the same time courage and will power of Mrs. Amiya Pathak Borpujari and Mr. Joy Prakash Borpujari. The fight to develop their only child Rituparna (Pahi) like other children compelled them to move hither and thither for treatment in various hospitals of India. Their experience and advice received from the doctors inspired not only to develop their child but also to extend helping hands to those parents who waited for someone to come with their angelic help. As a result, Mrinaljyoti Rehabilitation Centre was established in January 1999 with the help of well wishers of Naharkatia, focusing to fight for the rights of Persons with Disabilities, to offer them different rehabilitation services so that they can live their life with dignity. In 2000, Mrinaljyoti was shifted to Duliajan, Central Namghar campus and in the same year the District Administration handed over a plot of land measuring 5 acres. Mrinaljyoti has crossed seventeen glorious years in the service of thousands of Special Children.

Our mission is to bring all the people of the society together irrespective of socio economic, cultural, demographic and religious divisions to join hands for the welfare of the people with disabilities. Mrinaljyoti is the sole organization working in the field of disabilities by providing early intervention, physiotherapy, speech therapy, education, residential services, vocational training and outreach programmes in upper Assam and parts of Arunachal Pradesh to ensure a dignified life for people with disabilities.

Our continuous effort to create awareness among the people ,to detect newborn babies with delayed development and to help them get maximum support services and other field activities have elicited good response from the public and many people are coming forward to help these children and to protect their rights.

The achievements of Mrinaljyoti during the last 17 years were possible only with the continuous support and guidance from various organizations like National Trust, NIEMPD, VRC, CRC etc. Further we always express our gratitude to Oil India Ltd, Duliajan Ladies Club, AGCL, NEEPCO, Zaloni Club, WIPS and many other organizations for their continuous support and goodwill. Many other individuals are also rendering tremendous support to us.

We are trying our best to bring all the facilities and trained personnel in various fields of disability under one roof so that we would be able to offer best services to the people. We proudly announce that Mrinaljyoti is now capable of helping more people with disabilities. At the same time we are quite aware that we have miles to go in the service of the people with disabilities.

Rehabilitation and continuous support of these Children are a major challenge for any one. Thousands of such children remain dependent for lifelong and a few are able to live independently and also earn their livelihood. Therefore, we are trying to offer short term vocational training sessions according to their ability so that after returning home they would be able to do some productive work on their own or help other family members.

ANNUAL GENERAL MEETING

The Annual General Meeting 2014-2015 of Mrinaljyoti Rehabilitation Centre was held on 3rd October 2015 at Mrinaljyoti Rehabilitation Centre, Duliajan. On this day Father G.P Amalraj, President of the organization presided over the 16th annual general meeting. Mr. S. N. Singh, E.D, Oil attend the meeting as a guest of honour. Moreover Mr. P. S. Mr. Joy Prakash Borpuzari, Director, in his speech informed the General Board members that in the previous year, Mrinaljyoti achieved a lot like construction of the girls hostel with the help OIL. Signing MOU with Foundation for Social Transformation and Arunachal University of Studies. Signing partnership with 11 NGOs and 3 INGOs for Inclusive Education in North-East India and starting a separate centre for Autism and Hearing Impaired children. Moreover, he also informed that the organization is focusing on the appointment of trained professionals in this field.

In the meeting the "G.R. Nihalani Scholarship" was handed over to Gargi Kakoty by Mrs. Anita Nihalani in the name of her father in law.

At the end of the meeting the Secretary of Mrinaljyoti Mrs. Amiya Pathak Borpijari offered her heartfelt thanks to all the members, dignitaries, parents and staff for their continuous association with Mrinaljyoti Rehabilitation Centre.



ACTIVITIES

Unit I : SCHOOL

Here we are happy to announce that from the January 2016 Mrinaljyoti Rehabilitation Centre is a partner of "Regional Action on Inclusive Education in North East (RAISE-NE)", a project initiative to complement the programme as Sarba Siksha Abhiyan on inclusive education to improve the quality of education for the children with disabilities in government/government supported schools in selected districts of Assam, Meghalaya, Manipur, Nagaland and Tripura. The project is supported by 3 international agencies i.e. CBM (Australia), LFW (Austria) and Liliane Fonds (Netherland). We are proud to be a part of RAISE-NE project and have already started the initial preparation at our centre. Usually earlier the children were taught accordingly to their disability. After being a partner of this project Mrinaljyoti has successfully converted its special school as a full fledged inclusive school from January 2016.

As an organization working for the children with disabilities, we offer our school services excluding Visually Impaired to children with Mental Retardation, Multiple Disabilities, Cerebral Palsy, Autism, Learning Disabilities. In addition to that as there is no educational centre for hearing impaired in this part of Assam, we try to offer basic education to such children too. Admission in the institute is open throughout the year. The number of students was 93 in the year 2015-16 at our school.

As we are in partner with the RAISE-NE project and that we have converted our special school to an Inclusive school from January 2016. A glimpse of the work as a inclusive school done till March 2016 is listed below:

The students of Mrinaljyoti Rehabilitation Centre have been now allotted their classes according to their ability and age factor irrespective of disability. We have been trying to give admission to the drop out children from the nearby regular schools. A detail survey has been conducted in this regard and we could successfully bring 4 children without disability in the inclusive school setup. Our efforts are on to continue to bring more such under privileged children in future. The regular curriculum of Jatiya Bidalaya is now adopted by Mrinaljyoti. Now it has been an inclusive school with regular syllabus.

- A school Management Committee (SMC) has been newly formed for the independent and better working of the school.
- Two subcommittee are also formed under the SMC i.e. School Safety Committee and Child Protection Committee.

Unit 2 : EARLY INTERVENTION UNIT

Mrinaljyoti Rehabilitation Centre gives top priority to Early Identification and early intervention. We offer awareness, assessment, therapeutical interventions and referral services. We have our own physiotherapist, speech therapist, special educator, counselor and guest neuro-developmental therapist in our early intervention unit. We mainly focus on school readiness program therefore we offer early intervention to children with disabilities within the age group zero to six years. Also those adults suffering from disabilities who come to us are provided therapeutical intervention. In the year 2015-16 the centre was equipped with various therapeutic instruments along with Audiometry Centre. The number of new admission was 13 in the year 2015-16 at our early intervention unit.

The early intervention unit has been offering various therapeutical management to children with disabilities from the very beginning. Many such children showed good results and were inducted into regular schools after they left the institute.

Unit III : SPECIAL CHILDREN HOME (Jyoti Niwas)

At present, there are 20 boys and 10 girls in Jyoti Niwas Children Home of Mrinaljyoti Rehabilitation Centre. Demand for hostel seat is growing day by day but it is not possible to accommodate all the students as the seats are limited. We are very thankful to Oil India Limited as with their support we have completed the construction of new Girls' Hostel building which was inaugurated by the Sri Jayanta Kumar Borgohain, Resident Chief Executive, OIL on 20th January 2016. Our children home is recognized by the Social Welfare Department, Govt. of Assam.

Unit IV : VOCATIONAL UNIT

The vocational unit of Mrinaljyoti Rehabilitation Centre is now regularly provided with various training on skill development to persons with disabilities. A skill Development programme was being organized in Rajgarh unit by Composite Regional Centre (CRC) with the initiative of Mrinaljyoti Rehabilitation Centre, Duliajan from 18th to 20th August 2015 for adult PWDs. 40 adult PWDs participated in the programme (jute made product). Mr. Pawan Kumar, vocational Instructor from CRC, Guwahati was present in the programme.

We are happy to announce that this year, the vocational unit of Mrinaljyoti Rehabilitation Centre offered a 2 months skill development training on food processing and tailoring in association with Composite Regional Centre, Guwahati. Where different categories of persons with disabilities participated from Rajgarh and nearby areas. All total, 30 trainees were trained up within these 2 months. The training was held from 11th January to 10th March 2016. In view of the livelihood of these persons with disabilities, Mrinaljyoti is trying to build different SHGs among these persons so that they live a life of dignity in near future.

Unit V : OUTREACH SERVICE

Mrinaljyoti Rehabilitation Centre has started to run an outreach centre at Rajgarh from the year 2015. The outreach centre gives therapeutical interventions, education and creating mass awareness among the local community. This unit is also looking after the network with different governmental and non-governmental agencies that the persons with disabilities can get their rights and provisions from the society. Total numbers of beneficiary at this centre is 63.

We are also happy to announce that Mrinaljyoti Rehabilitation Centre has newly setup an outreach centre at Digboi. The inauguration ceremony of this centre was held on 19th February 2016 at Golai Gaon Panchyat in the presence of Sri Lila Ram Doloi, Officer-CSR, AOD, Panchyat Officials, local resource persons, representatives, parents and persons with disabilities from Digboi area.

The outreach units in Rajgarh, Dibrugarh district and Digboi, Tinsukia district of Assam also focus to facilitate the creation of responsive community and development of inclusive services, which fulfill the rights of persons with disabilities.

TRAININGS AND WORKSHOPS CONDUCTED BY MRINALJYOTI REHABILITATION CENTRE AT A GLIMPSE

Regional Parents Meet of Persons with Disabilities

We are honored to organize a 2 days' Workshop on "North East Regional Parents Meet" on 23rd and 24th January, 2016 with the help of PARIVAAR, Bangalore and NIMH, Secunderabad at B type Sarbojonin Puja Mandap, Duliajan. In total around 204 delegates, resource persons, dignitaries & media persons from 4 states i.e. Assam, Nagaland, Arunachal Pradesh and Meghalaya participated in this regional parents meet. The objective of the program was to create awareness and strengthen the parents of Persons with Intellectual and Developmental Disabilities (PwIDDs).



The meeting highlighted on the following issues :

1. Rights and legal entitlements of PwIDDs.
2. Role of self advocates in realizing their rights.
3. Formation of SHGs and livelihood schemes for PwIDDs and their families
4. Skill development Training and employment for PwIDDs.
5. Capacity buildings of parents association and NGOs working in the IDD sectors.
6. Life-long care facilities for PwIDDs
7. Role of parents in development of PwIDDs and
8. Local issues

It was a great and unique experience to organize such an event within a short period in a small area like Duliajan. All the members of Mrinaljyoti felt highly privileged to hold such kind of national level program for the first time in Upper Assam. When parents of PwIDDs and all the delegates got together under one roof and exchanged their views and experiences on awareness, certainly a variety of experiences were gained.



Health Services

Oil Hospital, Duliajan, offers regular free medical Checkup to our Children and provides medicines and hospitalization facilities on emergency. This year St. Lukes Hospital, Tinsukia extended their support towards PwDs in association with us at Rajgrah and Duliajan. Corrective surgery and free treatment at St Lukes Hospital is now available through us for PwDs (terms & conditions applied). Mrinaljyoti provided free health check up and treatment to 218 beneficiaries in the year 2015-16. Moreover, Mrinaljyoti received services from Chalakotoky-SD & Kacharipather PHC from time to time.

Parents counseling and Training

By giving birth to a child with disabilities, the life of parents along with the child becomes miserable. In many cases it is seen that the woman giving birth to a child with disabilities is regarded as sinner and has no right to stay with the family. In many other cases, the women is allowed to stay with the family like a slave. No one comes forward to support her.

Ego problems of many middle class families, makes a child suffer. We try to motivate such people to realize the real fact and try to change their attitude towards the child and mother and extend our support service going to the family, meeting the people of the locality as a part of our objective. Apart from Regional Parents Meet Mrinaljyoti organized 3 (No. of beneficiaries 111) parents meet at its centers.

Field Activities

Survey and detection of Special Child and Adult with Disabilities is a regular process of our Organization. After detection we try to assess the needs of a child and try to offer support services with what we have at the centre. Secondly, regarding the Adult PWDs we try to assess their needs and help them by supplying assistive devices so that he/she would be able to live a dignified life. In many time we have organized short term training sessions for adults like Cycle repairing, Tailoring, Welding, Food processing etc to make them open an avenue for earning. To make our objectives a successful one and to minimize unemployment problem among Adult with Disabilities we are trying to establish a permanent vocational centre at our premises.

Aids & Appliances assessment camp

In the year 2015-16, Mrinaljyoti Rehabilitation Centre organized 3 aids and appliances assessment camp in collaboration with ALIMCO. For this noble cause, ALIMCO, Kanpur provided 2 experts for assessment. In a total of 351 Persons with Disabilities was identified for free distribution of aids & appliances like tri-cycle, wheel chair, CP chair, Behind the ear hearing aid, crutch, smart phone, electronic white can stick, and tablets. The approximately worth of aids & appliances for distribution was Rs.48,60,000.00 . The date & venue of the camps were as below:

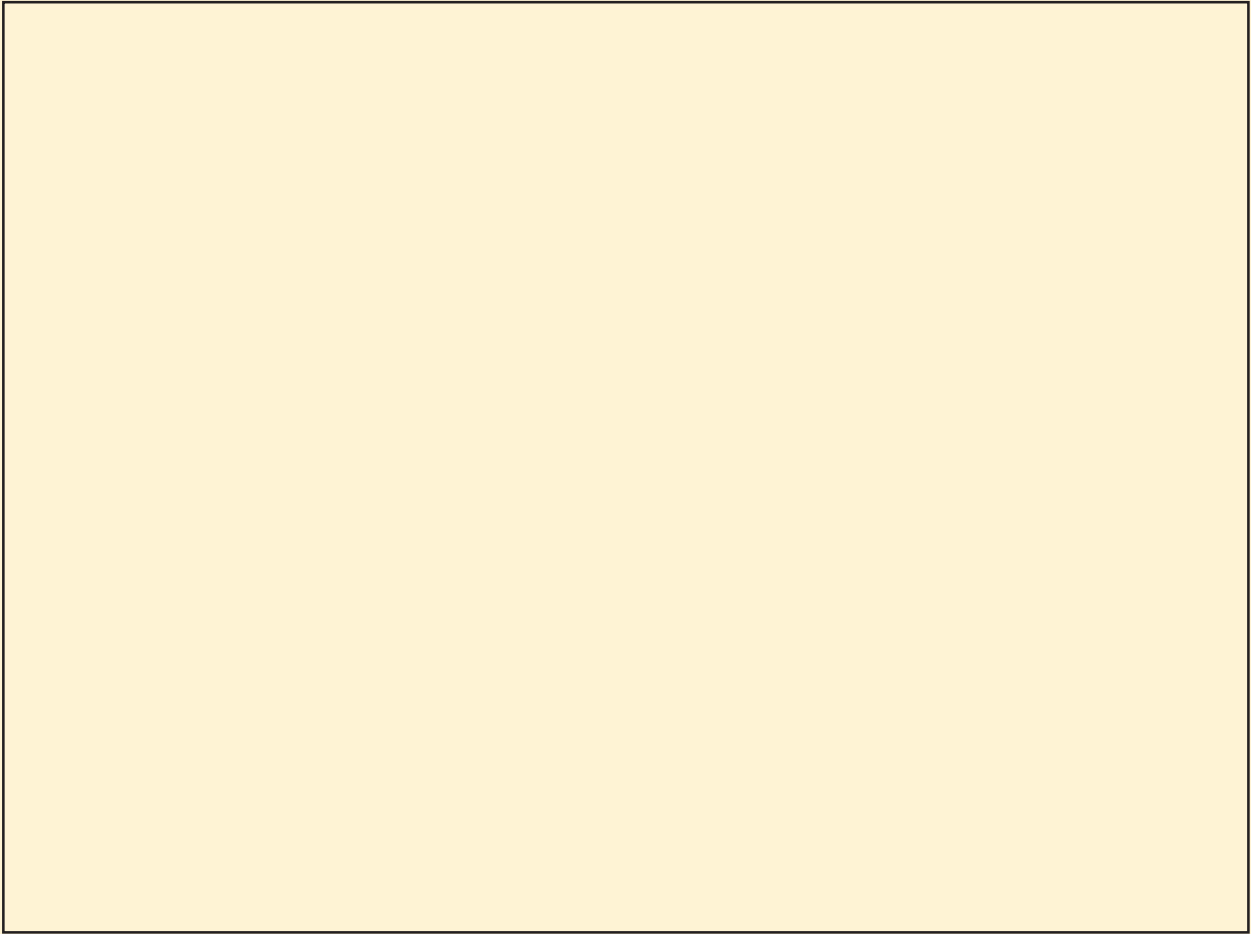

On major decision agreed by all members present over the meeting that Mrinaljyoti is going to create awareness programe, not only on disability but also on another social issues which is also responsible in increasing disability in Dibrugarh, Tinsukia and parts of Arunachal Pradesh. In this meeting another two upcoming important events were discussed i.e. World Disabled Day celebration and Regional Parents Meet.
- **17-09-2015** : This meeting was held mainly on preparation of World Disability Day celebration on 3rd December, 2015.



- **10-12-2015** : The committee approved appointment of Mr. Biplob Parashar Khound as a Deputy Director and Mrs. Jyoti Sinha as a Vice Principal. In this meeting the executive committee was approved the School Management Committee, Child Protection Cell and School Safety Committee of Mrinaljyoti. Another important decision was taken to inaugurate the new girls' hostel building and reformed early intervention centre by January 2016. It was initiated in the meeting to open an out-reach centre in Digboi. A few more topics were discussed on staff appraisal system, staff identity card, fund raising, developing record keeping

procedure, field visit, developing colour logo and letter pad of mrinaljyoti. The committee took the resolution to apply for grant in aid from governments and for FCRA registration.

- **02-01-2016** : The committee discussed on the upcoming aids & appliances assessment camps and the regional parents' meet. The secretary informed all the committee members about the appointment of RAISE-NE staff.
- **18-03-2016** : At first the committee members took a resolution to bring and carry forward so as to monitor the activities as well as the financial matter of RAISE-NE project. The committee discussed about distribution of aids and appliances of 3 assessment camps held in January 2016 and all members agreed that it will be distributed after the upcoming Assembly Election. The committee also discussed about the SMC, CPC, SFC, and other services of Mrinaljyoti and gave suggestions for improvement in services.

2. Staff (Manpower)

Manpower is the key factor of sustainable growth and development of any organization like Mrinaljyoti. At present Mrinaljyoti Rehabilitation Centre has 37 members as manpower. Time to time different interns from various organizations and volunteers helping Mrinaljyoti to carry forward its mission. However non availability of trained manpower in Assam in this sector of disability is a major challenge for us.




